POZNÁMKA:

The second breach is a repetitive breach within 6 months following the month in which the last breach was detected.

The third breach is a repetitive breach within 6 months following the month in which the second breach was detected."

The period for which the security training was withdrawn shall not be counted in this period."

If a violation of a regulation or procedure by an unidentifiable driver is detected in a ČEPRO warehouse but if the identification of the carrier to which the driver belongs is certain, the matter will be resolved by imposing a financial penalty of CZK 2,000 on the carrier.
